**RESOLUTION ESTABLISHING CHANGES TO THE TRAFFIC REGULATION
CODES FOR NO PARKING ZONE ON MAIN STREET, CAMBRIA;
NINTH STREET AND TENTH STREET, LOS OSOS;
FRONTAGE ROAD, TEFFT STREET AND VISTA DEL RIO, NIPOMO;
RESERVOIR CANYON ROAD, SAN LUIS OBISPO;
PARKING RESTRICTION WITHIN THE TOWN OF AVILA BEACH;
AND TURNING MOVEMENT RESTRICTIONS AT
CALLE CARMELITA AND CENTER STREET, SHANDON**

The following resolution is now offered and read:

WHEREAS, the County of San Luis Obispo seeks to ensure a safe and efficient road network; and

WHEREAS, the locations listed on Exhibit A have been reviewed in the field for operations and safety; and

WHEREAS, the Department of Public Works has determined that the road locations listed on Exhibit A warrant the actions proposed therein; and

WHEREAS, the Board of Supervisors is authorized to adopt the traffic regulations referenced herein by resolution pursuant to sections 32, 21458, 22101, 22500, 22502, 22507 and 22651 of the California Vehicle Code and section 15.01 of the County Code.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, the Traffic Regulation Code for the County of San Luis Obispo is hereby amended as shown on the attached Exhibit A by the addition of sections contained therein.

Exhibit A

Amendments to the Traffic Regulation Code
County of San Luis Obispo

The following sections are added to Chapter 15 of the San Luis Obispo County Traffic Regulation Code:

15.67.168 Main Street West of Cambria Drive, Cambria

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the northeasterly side of Main Street (County Road No. 5145) from a point 140' west of the centerline of Cambria Drive to a point 170' west of said centerline.

15.67.199 Tenth Street South of Santa Ynez Avenue, Los Osos

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the westerly side of Tenth Street (County Road No. 3045) from the centerline of Santa Ynez Avenue (County Road #3051) to a point one hundred feet south.

15.300.500 Restricted Intersection at Calle Carmelita and Centre Street, Shandon

Southbound traffic on Calle Carmelita (County Road No. 5551) shall be restricted from turning left over the centerline and entering Calle Carmelita (County Road No. 5397).

15.300.501 Restricted Intersection at Centre Street and Calle Carmelita, Shandon

Eastbound traffic on East Centre Street (County Road No. 5551) shall be restricted from turning left over the centerline and entering Calle Carmelita (County Road No. 5397).

15.400.016 No Parking of Non-Motorized Vehicles or Objects in Designated Parking Lanes
in Avila Beach

After signs are erected giving notice thereof, no person shall park or leave standing any non-motorized vehicle or object within a designated parking lane delineated by striping or parking tees on public streets or alleys in the town of Avila Beach unless authorized by an encroachment permit.

For the purpose of this regulation, the town of Avila Beach is henceforth defined as the area bounded by Cave Landing Road (County Road #2072) to the east, Avila Beach Drive (County Road #2070) to the north, Front Street (County Road #2076) to the south and Port San Luis Harbor and the westerly terminus of Avila Beach Drive (County Road #2070) to the west.

15.400.034 Ninth Street at Los Olivos, Los Osos

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location along the east side of Ninth Street (County Road No. 3200) from a point eighty-five feet north of the centerline of Los Olivos Avenue (County Road No. 3151) to a point sixty-five feet south of the said centerline.

15.400.239 Frontage Road South of Tefft Street, Nipomo

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the westerly side of Frontage Road (County Road No. 1035) from the centerline of Tefft Street (County Road No. 1018) to a point one hundred seventy feet south of the said centerline.

15.400.240 Tefft Street South Side east of State Highway 101, Nipomo

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the southerly side of Tefft Street (County Road No. 1018) from the centerline of the State Highway 101 Northbound off ramp (non-County Maintained Road) to a point two hundred feet east of the said centerline.

The following sections are modified from Chapter 15 of the San Luis Obispo County Traffic Regulation Code:

15.67.120 Reservoir Canyon Road, San Luis Obispo

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along both sides of Reservoir Canyon Road (County Road No.3118) from State Highway 101 (non-County Maintained Road) to a point two thousand three hundred and fifty feet south.

15.67.315 Vista Del Rio, Nipomo

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following locations: along the northwesterly and southeasterly sides of Vista Del Rio (County Road No. 1532) from the centerline of Hutton Road (County Road No. 1514) to the centerline of Moss Lane (non-County Maintained Road).

15.400.247 Tefft Street North Side east of State Highway 101, Nipomo

After signs are erected giving notice thereof, no person shall park a vehicle at any time at the following location: Along the northerly side of Tefft Street (County Road No. 1018) from the centerline of the State Highway 101 Northbound on ramp (non-County Maintained Road) to the centerline of Oakglen Avenue (County Road No. 1036).
