## 6. County and Local Agency Reports:

## A. Sheriff: Sgt. Abbas reports

- Ken Thompson voiced concern as to the monthly stats not adding up to printed report. Sgt. Abbas noted that many calls for service are not from Avila Beach proper. This will be followed in subsequent reports.

2 collisions occurred in August, mostly non-injury. 1 solo vehicle, another 2-car, non-injury collision.

## D. Planning: Nicole Ellis/Susan Strachan reports:

## E. Public Works: John Waddell reports:

- John Waddell advised that he will not be able to attend the meeting on Monday. There are no significant issues to update the committee.

## F. County Parks: Nick Franco / Shaun Cooper reports:

- Nick Franco advised that he will not be attending tonight but here are a few updates.
- Avila Park, Promenade, and Bob Jones trail was very busy this summer. Staff performed three restroom/trash runs daily to help keep areas clean and safe.
- Avila Park tot swing set support beam has been fractured. Parks is looking into funding options to repair or replace.
- The Avila Park restrooms have had multiple doors with failing hinges and county maintenance is working on door replacement.
- The benches throughout the park and throughout the promenade are in needed repairs. Rangers have making temporary repairs, but we are looking into a more longterm fix by replacing the benches with engineered wood rather than cement rather than concrete so that they will last longer and be easier to repair. The issue is that these don't conform to the Community Design Standards so will need to get some type of approval to deviate from those.

- Cave Landing Project Parks has submitted for the permit with building and planning and once that is approved, we have a contractor already lined up to begin the work. The project will take approximately 6 weeks and will be completed this fall.
- Ontario Ride Trail easements Supervisor Ortiz-Legg will give an update on this.

# H. County Supervisor: Supervisor Dawn Ortiz-Legg reports:

## Ontario Ridge Easements:

- On Aug. 23rd Board of Supervisors approved two resolutions authorizing perpetual easement agreements for the Ontario Ridge Trail in the unincorporated community of Avila Beach.
- Parks has been working with the property owners to acquire the necessary
   Ontario Ridge Trail easements to facilitate connectivity between the Cave
   Landing parking lot trailhead, and a future parking lot on Shell Beach Road, in
   Pismo Beach.
- An informal trail that currently exists across private property does not meet Parks trail standards.
- Executing these trail easement agreements does not immediately fully align the current informal trail and the easement. However, it does provide the opportunity to establish a future public trail consistent with sustainable design and permanently held for public use.

### • The Avila Community Plan Update & Clarifications:

- The Avila Community Plan Draft released April 2021did not meet community expectations due to poor layout and quality of content. The plan, compiled by a consultancy, was rejected by community and local businesses.
- Planning staff regrouped, and since has been making steady and consistent progress meeting regularly with the AVAC subcommittee to review and update the planning area standards and land use components of the Community Plan.
- A Second draft scheduled for release by March of 2023.
- Draft will be followed by an Environmental Impact Report and hearings before the Planning Commission, Board of Supervisors, and Coastal Commission.

#### Moratorium in Avila:

- There is not sufficient evidence for a moratorium to be initiated and subsequently held up in a court of law.
- For a moratorium to stop development, until the Avila Community Plan is adopted, to be legally defensible, the County would basically need to show that the current policy and zoning, which it has operated under for years, creates a current and immediate threat to public health, safety or welfare.

- This would be inconsistent to the findings for approval that the County has made on the many land use permits which have come before it for Avila.
- o Current projects in Avila are conditioned to address immediate risk.

# • Secondary Evacuation Route:

- The Diablo Canyon north access route is a "secondary route" not a road and designated to be used in an emergency should other routes be blocked.
- The north access route has the necessary qualities to evacuate residents and visitors in Avila.
- The County Office of Emergency Services is work with PG&E on a Memorandum of Understanding to memorialize. The MOU will formalize and finalize once and for all this important route.
- Further study can be included in the Avila Community Plan EIR on route(s) and number of hours each area will take to evacuate, depending on the disaster.
- The DC North Access Road will connect with Los Osos, and will serve for any declared emergency.
- San Luis Bay Creek water is safe and is constantly tested.
