• C-DRC2024-00039 (item 3 on the October Active/In Process list) A Development Plan Coastal Development Permit (C-DRC2024-00039) to allow for a new construction of a new 2-story mixed-use project with a 25-foot maximum height. First floor contains 928 square feet of commercial space and a 448 square-foot ADU with an adjacent carport. Second floor contains a 2,052 square-floor unit connected via elevator to a 577 square-foot, two-car garage. The project will require demolition of an existing two-story 1,522 square foot structure, with decking, existing perimeter fencing and will result in the disturbance of approximately 3,000 square feet on a 0.07 acre parcel. The proposed project is within the commercial retail land use category and is located at 502 First Street Avila Beach, California. The site is in the San Luis Bay Coastal Area Plan of the Coastal Zone. Application received 9/11/2024, Referral sent 9/20/2024. The information hold letter to be sent by 10/11/2024.

DIABLO CANYON POWER PLANT COMMITTEE PROJECT UPDATES

- DRC2021-00092 (item 6 on the October Active/In Process list). The Draft Environmental Impact
 Report (EIR) for decommissioning of the Diablo Canyon Power Plant was released on July 28,
 2023 for a 60-day public review period. The comment period ended on September 25, 2023.
 County Staff and Aspen Environmental Group are in the process of responding to the comments
 and make any necessary edits to the Draft EIR. The Draft EIR and comment letters received can
 be found at: www.slocounty.ca.gov/DCPPDecom. It is anticipated that the Final EIR will be
 issued in 2025 by the end of 2024. A Planning Commission Final EIR study session and hearings
 will be held after the Final EIR is released.
- C-DRC2024-00023 (item 7 on the October Active/In Process list). Proposed demolition and removal of an existing 500 sf. metal and glass Visitor Overlook structure located west of the Independent Spent Fuel Storage Installation (ISFSI) at Diablo Canyon Power Plant. The structure sits on a raised foundation of a retaining wall and concrete piles that will remain. The site is within the Coastal Zone and requires a Coastal Development permit for demolition of the structure.

Application submitted/fees paid 4/30/24. Referral request sent via email May 7, 2024. Project accepted for processing June 6, 2024. It was approved at the Planning Dept. Hearing on August 2, 2024.
